1. You are invited to submit your most competitive quotation for the following works.

2. The Danish Committee for Aid to the Afghan Refugees (DACAAR) has received financing from the World Bank (Bank) toward the cost of the Water Emergency Relief Project (WERP) and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this Request for Quotations is issued.
3. The Project is being implemented by Water Emergency Relief Project (WERP) Danish Committee for Aid to the Afghan Refugees (DACAAR).

### **Eligible Contractors**

1. In case the Contractor is a joint venture (JV), all members shall be jointly and severally liable for the execution of the entire Contract in accordance with the Contract terms. The JV shall nominate a representative who shall have the authority to conduct all business for and on behalf of any and all the members of the JV during the Request for Quotations process and, in the event the JV is awarded the Contract, during contract execution.

#### **a. Eligibility and Qualification Criteria**

- (i) The contractor shall have at least five years' experience
- (ii) Valid Registration License.
- (iii) **Annual Turnover:** The minimum required annual volume of construction work for the successful Bidder in two of the last 5 years shall be **5,280,000.00 Afghani.**

- (iv) **Similar Experience:** A minimum number of 1 similar contract of **3,080,000.00 Afghani** that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor in last Seven (7) years:
- (v) **Financial Capability:** The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, lines of credit, and other financial means, other than any contractual advance payments to meet:
- a) the following cash-flow requirement **1,100,000.00 Afghani**

**Note: the overall cash flow requirements for this contract and its concurrent commitments. In case of JV, all partners combined must meet 100 % of the requirement, each partner minimum must meet 25% of the requirements and Lead Partner Minimum must meet 40% of the requirements of (iii) & (v) above.**

- b) The Bid Security amount is: **136,000 Afghani.**
- c) The validity of bid security shall be at least 118 days from the date of bid submission deadline.
- d) The Bid Security of a JV must be in the name of the JV that submits the bid.
